## Proposed Additions and/or Changes:

### 3.1.17 Recruiting rules:

3.1.17.1 No coach, assistant coach, trainer, team representative, registered player, parent or advertisement may offer or provide any kind of inducement to recruit a player to their respective team.

3.1.17.2 Forms of inducement include but are not limited to free uniforms, offers of/ or guarantees of college scholarships or Olympic Development Program team placement, free or discounted travel costs, free or discounted professional coaching etc...if such costs are normally paid by the majority of the players associated with that particular team, club or organization.

~~3.1.17.3 Verbal discussions and individual engagement (including but not limited to phone calls, personal letters or emails, etc...) with players are not allowed until the completion of the state tournament.~~

3.1.17.3 Tryouts for the following year U-11's may begin in May as determined by the Association.

3.1.17.4 Tryouts for the following year U-12's and older will be held no earlier than the day following Memorial Day. and no later than July 31<sup>st</sup>. Any team conducting tryouts on dates other than the above will not be eligible to compete in WDDOA.

3.1.17.5 Failure to comply with the provisions of these rules may result in not less than a one (1) year suspension from all Association activities for the offending party. Complaints regarding noncompliance must be filed with the Executive Vice President and the WDDOA Discipline and Protest Committee shall render a decision regarding the complaint. Either party may appeal the decision of the WDDOA Discipline and Protest Committee according to the rules of this Association, STYSA and USYS.

~~3.1.18 No coach, assistant coach, trainer or team representative may allow an Association registered player who does not appear on his current roster to participate in any soccer related activity with them or their team unless such player has written approval from the coach or manager of record of his or her team.~~

~~3.1.19 If a coach allows a player currently registered to another Association team to participate in an organized or impromptu practice session or scrimmage without the prior permission of the coach of the team to which the player is registered, he **MUST** notify the coach of the team to which the player is registered in writing, communicated by fax, email or the U.S Postal System, within 48 hours of the player's participation, that the player in question participated in an organized or impromptu practice session or scrimmage. Submission of such notice does not prohibit the coach of the team to which the player is registered from requesting that the Association D & P Committee investigate the incident to determine any rule violations.~~

## SECTION II. JUSTIFICATION FOR THE PROPOSED RULE CHANGE:

The majority of DOC's in WDDOA requested the verbal and individual engagement piece be dropped from the rules as a compromise for WDDOA not being able to enforce contracts of play and employment. Rules 3.1.18 and 3.1.19 are removed on the same premise and request. Paragraphs are renumbered for consistency. As a reminder, Player Cards belong to the players. Managers or coaches withholding cards from a player wanting to guest play with other teams in tournaments is prohibited by STYSA Rule. Violation subjects managers or coaches to suspension.
